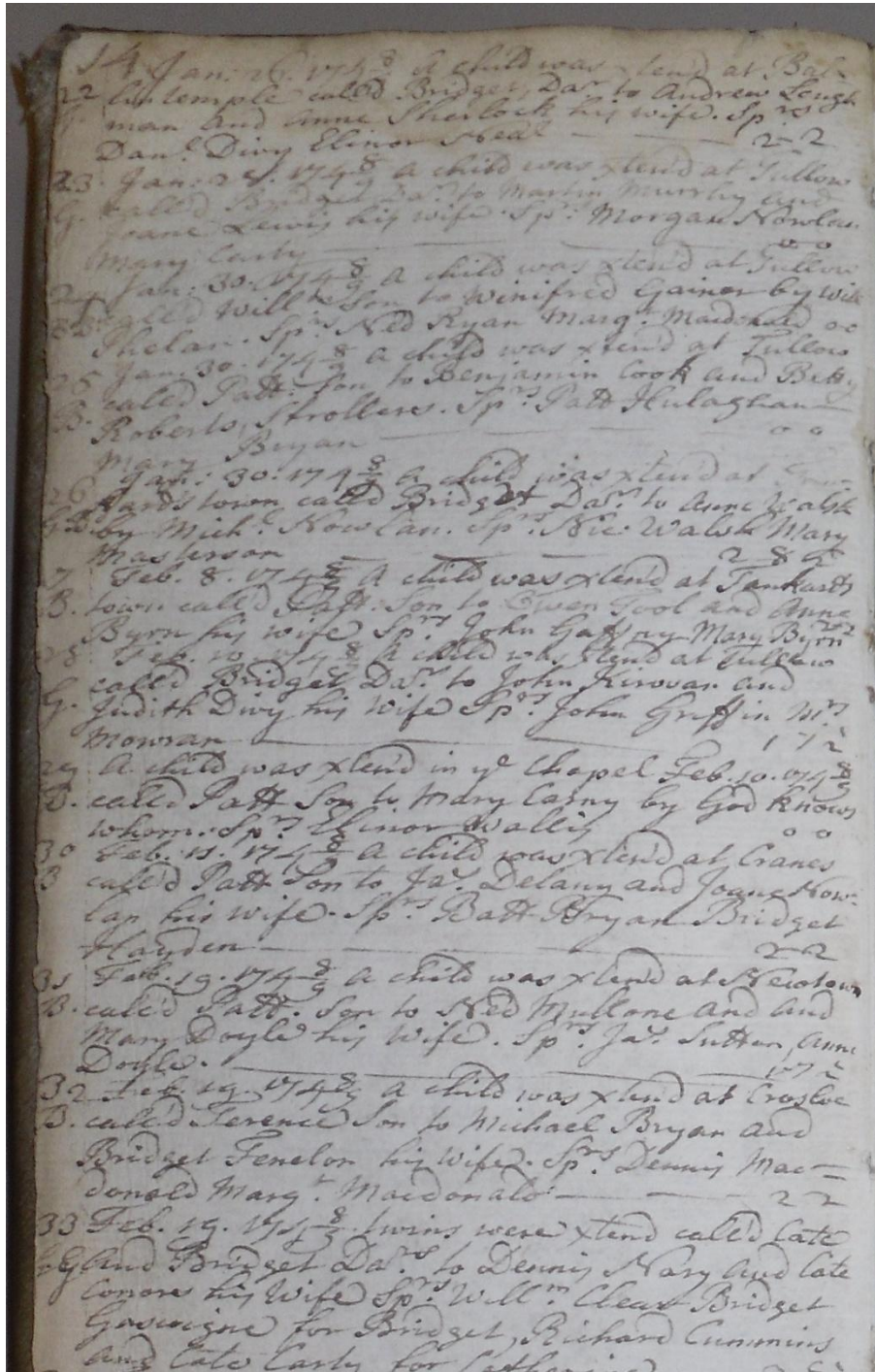

My Lord

It is my duty, respectfully and earnestly to entreat the attention of your Lordship to two Subjects which I deem of paramount importance to the Catholics of Ireland.

The first relates to the Education Census which has been for some time in progress under the auspices of "the New Catholic Association."

The second to the Establishment of the "New Catholic Trust for all public purposes not prohibited by Law"

I most respectfully submit to your Lordship the propriety of offering your Lordship's Countenance to both these important - and I sincerely trust - highly useful measures. Should I have the Misfortune to differ with your Lordship on these subjects, I implore you at all events to pardon the anxiety which smites me - as I now do most earnestly you very worthy and most esteemed supporters. Believe me my Lord that I make this request from an honest conviction of the paramount utility of these measures to our religion and country.

The "New Catholic Association" are extremely desirous to procure one or two Clergymen in your Lordship's diocese who would condescend to assist them to obtain speedy and accurate returns for the Education Census in each parish. And they would not think of requesting any of your Lordship's Clergy to give them this assistance unless they were fully convinced that such a measure would not meet your disapprobation.

They have at the other side to annex a list of the parishes in your Lordship's diocese of which we have obtained already the Census - They desire to inform your Lordship that the Prosecution of the 40th Statute has discontinued - and that we are much pained for relief by persons who suffer persecution for not sending their children to Protestant schools or who themselves refuse to be present at the same. We are deeply anxious to relieve all these persons - and believe me that if the New Catholic Trust on the one hand were universal it would afford abundant funds for these purposes.

Letter from Daniel O'Connell, Merrion square, Dublin (later Member of Parliament), to James Doyle (JKL), Bishop of Kildare & Leighlin, 2 January 1827. O'Connell appeals for the Bishop's support for two initiatives 'of paramount importance to the Catholics of Ireland': an education census which is in progress under the auspices of the Catholic Association; and the establishment of 'the New Catholic Trust for all public purposes not prohibited by Law.'

 not dedicated. They have 3 Choralists. Mem. Copy of 6 parts of 6 Messes
 and a library of 100 vol. Pr. Com: 3450. M. D. 300. and children edu-
 cated 446. There is no Messes and no Accommodation. Calverton
 and Messes -
 18th June year died Mr. M. Shilly who left a few pounds all that he possessed
 to be disposed by the 10p in Charitable uses, and left his library a schedule of
 which is here placed for the use of his Successors for ever. Mr. W. Murray is
 appointed his Successor.

For horses the best fee property of tenant farmers residing in Carlow, Kilkenny, Wexford, or Queen's County, and which have been in their possession before the 1st August, 1882; that have not won a race under Rules of Racing, a hurdle, or steeplechase value 50 sovs.; or trained in a public training stable since 1st August, 1882. The winner of 20 sovs to carry 7lb. extra, of 25 sovs. or collective fee value 45 sovs. to carry 10lb. extra. Starters to pay 10s. The Stewards reserve to themselves the right to define who is a bona fide tenant farmer.
