13 February 1832-18 July 1864

Minute book of the Governors and Directors of Carlow District Lunatic Asylum. Minutes frequently refer to financial matters and the admission, discharge and death of patients. Cause of death is infrequently recorded. Includes copy of order of the Lord Lieutenant and Privy Council nominating and appointing Governors and Directors of the Asylum. Index to names of Governors and Directors and their date of appointment at beginning of volume; minutes (20 February 1832) include resolution to accept handover of Asylum building from William Murray, architect; same minutes include inventory of furniture in Asylum, resolution that the rules used at Armagh Asylum be adopted, and name Meade Nisbett Stone, medical doctor, as Physician, and Francis Crofton as Manager / Superintendent; minutes (22 March 1832) refer to the setting of salaries and allowances for the Manager and Matron. Salaries are to be £225 and £100 sterling per annum respectively. Allowances refer to coal, candles, milk and washing; minutes (3 May 1832) include resolution that the Asylum is now in fit state to accept patients. Same minutes refer to letters received from Richmond Lunatic Asylum, Dublin, and jails for the city of Kilkenny, county of Kilkenny and county of Carlow for the admission of patients. Elizabeth Freeman is named as Matron; minutes (2 August 1832) state that if the Matron has occasion to leave the Asylum, she must first have the consent of two Governors, who shall not give their consent without first communicating with the Manager; minutes (1 October 1833) contain reference to new Matron, Lavinia Parsons; minutes (2 September 1834) allude to death of Francis Crofton, former Manager, on 20 August 1834; minutes (7 October 1834) refer to appointment of Patrick McCaffry as Manager. Salary set at £150 with same allowances of horse keep, milk, coal and candles enjoyed by former Manager; minutes (4 July 1835) include transcription of letter dated 5 June 1835 from William Abraham, House of Industry, Brunswick Street, Dublin, to George Howard, Viscount Morpeth, Chief Secretary for Ireland. Abraham was formerly employed as a cook at Carlow District Lunatic Asylum. He alleges fraud by staff of Carlow District Lunatic Asylum, that is, 'converting provisions to other purposes than to what it has been allowed,' and harsh treatment. Interviews of staff find no basis for further investigation; minutes (2 February 1836) include description of livery to be worn by male Asylum servants as coat of blue cloth with red collar and cuffs, with the Institution button, and vest of blue cloth with similar buttons; same minutes include resolution that no servant is permitted to bring their children or other family member to reside in the Asylum, and that no such person will be admitted as a visitor except on Mondays and Thursdays between eleven and one o'clock; minutes (5 May 1836) state that Dr Matthew Esmonde White has produced to the Board the Lord Lieutenant's warrant appointing him Physician to the Asylum; minutes (18 October 1837) refer to proposal to erect a small detached infirmary; minutes (20

December 1837) refer to repeated complaints of patients escaping the Asylum grounds by climbing trees adjoining the Dublin Road wall. Propriety of cutting the trees to be discussed at next meeting; decision (17 January 1838) is to pale off the area, it being intended as a working garden for female patients. Warders are to be fined 10 shillings for first escape of a patient in their care, and dismissed for a second escape; minutes (20 May 1840) state that it appears to the Board that there is reason to suspect that practice has arisen of committing minor breach of peace resulting in jail committal, as fastest way to gain entry to Asylum. Reference to man who has been waiting for admission to the Asylum for nearly a year. The Board believes that accommodation for an additional 50 patients is now required, there being currently in the Asylum 48 more patients than it was intended to accommodate; minutes (22 July 1840) state that a fresh notice is to be served [on friends or relatives of recovered] patients, and if patients are not removed from the Asylum before 1 August, legal proceedings will be instituted to enforce bonds; minutes (16 June 1841) state that there are now 54 more patients than Asylum was intended to accommodate. No one else can be admitted unless the 'comparatively harmless patients be withdrawn into the District Poor Houses when the same shall be fit for the reception of Paupers'; minutes (17 November 1841) note that servants who have become teetotallers may be supplied with tea to same amount as beer ration which they previously enjoyed; minutes (16 November 1842) refer to 'certain serious charges' preferred by Thomas Keefe on behalf of his daughter, Mary Keefe, against Patrick McCaffry, Asylum Manager; minutes (28 November 1842) record decision of the Lord Lieutenant that McCaffry cannot with propriety continue in his position. Two keepers and a nurse also dismissed. Same minutes record appointment of William Parsons, Carlow, as temporary resident Manager; minutes (21 December 1842) record details of a patient whose father is willing to pay expenses of care rendered by the Asylum. Some Governors doubt the legality of accepting such payments notwithstanding precedents set by Richmond and Maryborough (Portlaoise) Asylums, and other institutions. Ordered that case be referred to the law officers of the Crown; minutes (15 February 1843) refer to medical attendance on Mary Keefe as she is in labour. Same minutes record decision that female servants will forfeit their situation if they contract marriage without sanction of the Board; minutes (17 May 1843) state that patient committed suicide by hanging; minutes (11 June 1845) record decision that the 'electro magnetic apparatus' recommended by Dr White be purchased for sum not exceeding £4.4.0.; minutes (7 December 1845) include details of disagreement between Physician and Manager respecting admission of patient by order of the Physician. Rules state that Physician can only admit patients in cases of urgency and all other admissions are by order of the Board. It is stated that that there is no urgency in this case, and that the Physician's objective appears to be to establish a right independent of the Board; minutes (21 October 1846) refer to memorial of male servants for additional ration of bread in lieu of potatoes. Ordered that they be allowed two pounds of bread each day in lieu of potatoes and bread. Same minutes refer to death of George O'Farrell, bread contractor. His widow, Barbara O'Farrell, appears before Board and represents the unreasonableness of expecting her to supply the Institution with enormous quantity of bread consequent on the failure of the potato crop. Minutes also refer to negotiations on price of bread contract; minutes (28 March 1848) refer to appointment of Dr Matthew Esmonde White to office of Manager in place of William Parsons, deceased; minutes (17 October 1849) refer to appointment of Thomas O'Meara, Esquire, medical doctor, as Visiting Physician, in place of Dr John

Tuomy, deceased; minutes (21 November 1849) include transcription of memorial by Timothy Brenan, accountant and storekeeper, seeking salary increase; minutes (20 November 1850) refer to fact that for some time, the Board has been considering lighting the Asylum with gas; decision (8 January 1851) that gas lighting is preferable to candles on cost grounds. Board is agreeable to the number of lights (82) as furnished by Dr White; minutes (14 August 1852) record decision to write to Colonel Henry Bruen, Oakpark, Carlow, to seek sale or lease to the Board of land adjoining the Asylum to be used for 'affording healthful occupation to the patients'; minutes (20 November 1854) include statement by Robert Cassidy, Governor, that at next monthly meeting he will propose that two warm baths be erected for benefit of patients; minutes (15 August 1855) record that Dr White is call on the County Surveyor to inspect the Asylum and to give plan and estimate for erection of infirmary; minutes (19 November 1856) include transcription of memorial by Robert Clayton Browne, Chairman, to the Commissioners of Lunacy, regarding inadequacy of accommodation at the Asylum, and proposing that additional accommodation be provided. Counties Carlow and Kildare are willing to pay their due proportions. It is submitted that enlargement of the Asylum at Carlow would be more economic than building a new asylum in Wexford, as recently proposed. Index.

15 August 1864-9 January 1871

Minute book of the Governors and Directors of Carlow District Lunatic Asylum. Minutes frequently refer to financial matters and to the admission, discharge and death of patients. Cause of death is infrequently recorded. Minutes (19 December 1864) include transcriptions of memorials received from several members of staff objecting to their proposed retirement and superannuation; minutes (16 July 1866) refer to death of the late Resident Medical Superintendent, Dr Matthew Esmonde White, on 26 June 1866, and appointment of Dr Michael Patrick Howlett, New Ross, County Wexford, as his successor; minutes (17 September 1866) refer to escape of patient from the Asylum. Warder Kelly is fined 10 shillings for neglecting to inform Dr Howlett that person resembling the patient was seen in the neighbourhood of the town on night of escape, or acting on the information himself; minutes (18 March 1867) refer to death of Timothy Brenan, clerk and storekeeper. His son, John Brenan, is appointed as replacement; minutes (30 May 1867) include transcription of letter from John Dunne, Secretary, to the Inspectors. It states that, heretofore, the Asylum Manager has appointed subordinate officers and Dr Howlett appointed John Brenan as clerk and storekeeper. Board is surprised that a John Abraham has come down as having been appointed to same position by his Excellency [Lord Lieutenant]. Board requests that irregular appointment of Abraham be cancelled; minutes (16 September 1867) refer to letter from Inspectors to Board. Appointment of John Brenan is annulled and that of John Abraham confirmed; minutes (13 January 1868) include resolution of Board to Government. Asylum is full and there are difficulties surrounding securing accommodation in external premises. In view of fact that new asylum is to open at Enniscorthy, County Wexford, within two weeks, Board recommends that new committals of patients from Wexford should be made to

Enniscorthy; minutes (8 February 1869) include resolution regarding proposed additional accommodation. Described as day rooms and associated dormitories for 100 additional patients, new dining hall, and addition to kitchen and laundry comprising bathrooms, privies connected into water closets, repairs to roof of main building, re-arrangement of system of drainage, new main sewer and relaying old subsidiary sewer; minutes (15 March 1869) include resolution that sum of £900 be borrowed for alterations, and an additional sum not exceeding £500 is necessary to put the building into repair. Furthermore, due to prospect of change in law respecting lunatic asylums, proposed additions to main building are deferred for this year; minutes (19 September 1871) include order that John Abraham is to be paid sum of £25 in consideration of acting as clerk of works for the new building; minutes (17 October 1870) include order that sum of £850 be insured on the building and contents of the new dining hall, kitchen etc. Also resolved that the Board is opposed to the separation of Carlow and Kildare, and requests meeting with Lord Lieutenant and other parties to discuss the matter.

10 January 1870-10 October 1873

Minute book of the Board of Governors of Carlow District Lunatic Asylum. This is a pre-printed minute book. There is some overlap between this minute book and SDH/001/002 which contains minutes dating from 15 August 1864-9 January 1871. Minutes include returns regarding number of patients, for instance, number of males and females, discharged, died, escaped, under treatment for medical and surgical diseases, number of patients for each of Kildare and Carlow; tables naming patients recently admitted, discharged, escaped or died; observations on patients' conditions or cause of death; accounts treating of income and expenditure; salaries and pensions to named persons included under expenditure; report of Resident Medical Superintendent on health of inmates and general condition of institution; report of Governors who visited the Asylum; details of incoming correspondence and action taken by Board thereon. It is noted (15 August 1870) that there are currently four cases of cholera; submitted (19 September 1870) that owing to overcrowding on male side of house, necessary to open barn again for reception of patients. Ordered that estimate for fitting up the barn be prepared for next meeting. Cholera is referred to as 'Autumnal Cholera'; rates of wages (9 January 1871) set for employees holding the following positions: four warders, one yardman and messenger, four deputy warders, one gate porter, four head nurses, five deputy nurses, one assistant laundress, one deputy assistant laundress and one boardroom maid; proposed (24 July 1871) that two separate chapels be erected; resolved (21 August 1871) that Miss Parsons be appointed to do the duties of Matron for the interval between the death of the late Matron [Lavinia Parsons, her mother] and the appointment of a successor; attendance (18 December 1871) of George Wilkinson, architect, regarding tenders for new buildings. Tender of Messrs Ryan, Waterford, contractor, of £11,455 accepted; minutes (19 February 1872) note contents of letter (2 February 1872) received from Board of Control regarding loan of £13,000 which has been applied for to complete building works which are described as '2 wings capable of

accommodating 150 additional patients. Erection of two separate Chapels - [Foundation] of new main drain'; resolution (19 February 1872) that the probationary appointment of Mrs Mary Ellison to the office of Matron be confirmed; minutes (15 July 1872) include report (6 July 1872) of visit to Asylum by J. Nugent, [Governor]. Mentions that building work has begun after lengthy delay; minutes (9 May 1873) record contents of letter (6 May 1873) received from George Wilkinson, architect, submitting plans of farm offices for approval.

Minute book of the Board of Governors of Carlow District Lunatic Asylum. This is a pre-printed minute book. Same type of content as SDH/001/003. Includes reference (14 May 1880) to proposal to install water tank to supply water in case of fire. Recommended by George Wilkinson, architect. Estimate, plan and specification requested from Wilkinson; reference (9 July 1880) to one patient being killed by another, 'by a blow of a sweeping brush'; reference (8 October 1880) to the death of Dr Howlett, Resident Medical Superintendent, on 22 September 1880 at Cheekpoint, County Waterford; retirement (10 December 1880) of Dr O'Meara as Visiting Physician after 33 years in the post, and election of Dr C.W. McDowell, B.A. M.D. F.R.C.S.I. L.A.H. as his successor; direction (14 January 1881) to Dr O'Meara to apply for the occupational pension of a patient in order to defray the cost of his maintenance in the Asylum; reference (11 November 1881) to a patient being delivered of a baby; reference (14 July 1882) to day rooms in the Asylum which have been built recently.

Minute book of the Board of Governors of Carlow District Lunatic Asylum. This is a pre-printed minute book. Same type of content as SDH/001/003. Includes approval (13 July 1883) of suggestion by Dr O'Meara to substitute soil wagons for cesspools in the three privies of that construction which remain; minutes (13 July 1883) include

consideration of the Lunatic Poor (Ireland) Bill now before Parliament: 'We think them in some respects inadvisable. We also look with grave suspicion on the tendency which the Bill appears to foreshadow with a considerable increase in the Rates paid by a community already overburdened.'

12 November 1886-8 August 1890

Minute book of the Board of Governors of Carlow District Lunatic Asylum. This is a pre-printed minute book. Same type of content as SDH/001/003. Includes report (10 December 1886) that the Resident Medical Superintendent is seriously ill with typhoid. Believed that he contracted it in the Asylum; minutes (13 May 1887) refer to James Byrne being requested to draw up a specification for the substantial repair of the roofs of the main buildings of the Asylum, including the roofs surrounding the several yards; minutes (13 February 1888) note that during the previous month, 22 patients died, including 13 from dysentery; minutes (21 December 1888) refer to proposal for supply of water to the Asylum; minutes (8 March 1889) approve of plan and estimate prepared by Mr Quilton [Edward Tankerville Quilton, Carlow County Surveyor], for supply of water for purposes other than cooking and drinking. Proposal is to take water from the river Barrow to the Asylum by means of a gas engine. Quilton is to communicate with the Barrow Navigation Company to ascertain if they will allow the proposal.

12 September 1890-13 July 1894

Minute book of the Board of Governors of Carlow District Lunatic Asylum. This is a pre-printed minute book. Same type of content as SDH/001/003. Minutes (13 February 1891) refer to resignation of Mary Ellison, Matron, due to failing health; minutes (4 March 1891) state that the salary of the new matron is to be £75 per annum with allowances of £65; minutes (8 May 1891) refer to election of Miss Lucy Woods as Matron on probationary basis for three months; report of the Resident Medical Superintendent (11 September 1891) states that there are now '23 Inmates over the utmost limit of accommodation on the male side. There are eleven vacancies on the Female side'; minutes (27 November 1891) refer to delay in structural alterations and improvements at the Asylum. Board of Control rather than the Governors now directs such works. Same minutes refer to change in diet at the asylum; minutes (8 January 1892) sanction employment of a musician for one night a week at remuneration of £0.2.6; minutes (8 April 1892) refer to resolution passed in response to resolution passed by the Board of Governors of Cork District Lunatic Asylum on 7 March 1892: 'The Governors of the Carlow District Lunatic Asylum have noticed a new Privy Council Rule, dispensing with the services of the Visiting

Physician, hitherto forming a most important connecting link between the the public at large and the lunatic asylum - a connection which has inspired mutual confidence.... The Governors would therefore hope that His Excellency may on further consideration direct that this Rule of His Privy Council be cancelled'; report of the Resident Medical Superintendent (12 August 1892) refers to death of escaped patient which was caused by being struck by a train; minutes (12 August 1892) refer to fact that Governors are willing to accept proposal to have the Asylum lit by electricity. A more specific agreement is to be drawn up; minutes (9 September 1892) include transcription of letter date 9 September 1892 from J. Frederick Lecky, Secretary pro tem, Board of Governors, to the Board of Control, regarding the need for a place of worship for members of the Church of Ireland. At present, Divine Service is held in a dining room. Requests that portion be set aside for a chapel when alterations made to Asylum.

Minute book of the Board of Governors of Carlow District Lunatic Asylum. This is a pre-printed minute book. Same type of content as SDH/001/003. Minutes (11 November 1898) refer to sanction for enlargement of Roman Catholic chapel and erection of Church of Ireland chapel; reference (10 February 1899) to installation of telephones at the Asylum. Cost of same is £107.2.2.

11 July 1900-8 January 1902

Minute book of the Board of Governors of Carlow District Lunatic Asylum. This is a pre-printed minute book. Minutes include names of Committee members who are present; receipts reported by Treasurer at last monthly finance meeting; payments ordered by Committee at last monthly finance meeting; summary and reconciliation of Treasurer's account, including payments made at finance meeting; return of state of asylum for the month (that is, numbers of patients); information regarding newly-admitted patients; information regarding patients recently discharged, escaped and

died; reports of Resident Medical Superintendent; report of members of Committee; tenders; communications from the Government, Inspectors of Lunacy and others; applications for admission of patients; and special business. Minutes (9 January 1901) include proposal that Dr Patrick Foley, Bishop of Kildare and Leighlin, confer with [Thomas Francis] McNamara, architect, regarding scheme to enlarge the Roman Catholic chapel; reference (9 January 1901) to installation of radiators and heating appliances; minutes (13 February 1901) refer to discussion on proposed salary increase for Dr J.J. Fitzgerald, Assistant Medical Officer. Minutes refer to the greatly improved condition of the Asylum under his stewardship; inserted in the minute book are two reports (30 January 1901-9 February 1901) by sub-committees on the working of the Asylum, including workshops managed by a tailor, shoemaker and workmistress on the female side; decision (10 April 1901) to write to the 'clerks of the different Unions where they receive as insane patients inmates from the Counties other than Kildare and Carlow requesting these officials to direct the masters and medical officers [sic] attention to the fact that patients will be only received here who belong to either of the contributing Counties of the asylum'; decision (8 May 1901) that permission be given to Carlow Cricket Club to play four matches on the Asylum ground as an experiment, subject to the permission of the Resident Medical Superintendent as to timing, and that a minimum charge of 10 shillings for each match be made, and a charge of six pence per head for spectators. Income to be allocated to the recreation of attendants and patients; reference (14 August 1901) to the escape of a patient while out on a country walk; minutes (11 December 1901) that Patrick Darcy's tender of £1884.4.0 for building an addition to the Roman Catholic chapel was accepted with conditions; minutes (8 January 1902) state that the Committee are prepared to consider applications from six of the married members of the male staff to reside outside the asylum. The staff will have to satisfy the Committee that their houses are situated in a convenient place.

12 February 1902-13 January 1904

Minute book of the Board of Governors of Carlow District Lunatic Asylum. This is a pre-printed minute book. Same layout as SDH/001/011. Includes minutes (12 March 1902) which state that Mr Mitchell's tender for additions to Roman Catholic chapel was accepted, with reduction for the labour of patients; minutes (12 March 1902) detail letter from Patrick [O']Daly, Secretary of the Committee of the Gaelic League, disapproving of the appointment of foreigners as examiners in Irish under the Intermediate Board. Recorded that the Committee approved of the statement; minutes (10 September 1902) refer to refusal of Lucy Woods to resign her position as Matron. She shall continue to discharge her duties until the Lord Lieutenant gives consent to her dismissal. Resolution passed that Lucy Woods be given one month's notice; minutes (24 October 1902) state that Committee is satisfied that the month's notice given to Woods was sufficient. Resolved that Nurse Byrne be requested to continue to discharge the duties of Matron; minutes (12 November 1902) state that Dr Patrick Foley, Bishop of Kildare and Leighlin, is requested to ask Thomas Francis McNamara, architect, on what terms he would supervise the erection of external fire

hydrants and arrangements for the collection of rainwater from the roofs of the Asylum; minutes (14 January 1903) refer to resolutions passed in connection with removal of lunatics from Naas workhouse. Also refers to accommodation of imbeciles; noted (13 May 1903) that the Joint Committee regrets to learn of death of the late Resident Medical Superintendent, Dr T.P. O'Meara; minutes (13 May 1903) summarise contents of letter dated 8 May 1903 received from William P. Hade, civil engineer. He informs the Committee that the cost of materials, exclusive of single rooms, for improvements to the Asylum is £600. Hade recommends that single rooms be built by contract at end of the observation dormitories. Committee decides to defer decision on proposed single rooms; minutes (8 July 1903) record the election of Dr J.J. Fitzgerald as Resident Medical Superintendent and Dr Edward [J.] McKenna as Assistant Medical Officer. Both appointments subject to the sanction of the Lord Lieutenant; minutes (9 September 1903) note that Charles J. Engledow, Joint Committee member, has arranged to live in County Cork and will be unable to attend Committee meetings any longer.

10 February 1904-23 March 1906

Minute book of the Board of Governors of Carlow District Lunatic Asylum. This is a pre-printed minute book. Same layout as SDH/001/011. Minutes (10 August 1904) including approval of Committee for procurement by the Resident Medical Superintendent of medals for attendants who have passed the nursing examination of of Medico-Psychological Association; minutes (8 February 1905) refer to letter dated 2 February 1905 from [Richard] Jones, Chairman, Richmond Asylum, Dublin, regarding test case with reference to liability of the Crown for payment of the maintenance of army and navy lunatics committed to Irish asylums. Informs Committee that judgement has been made in favour of Richmond Asylum; minutes (10 May 1905) record decision to fix nine members for County Carlow and 14 for County Kildare as the proportionate representation on the Joint Committee of the Counties. These figures decided on as the daily average for the last three local financial years has been 151 patients from Carlow and 243 from Kildare; report (14 June 1905) of the Resident Medical Superintendent states that the workhouses of County Kildare are 'practically depleted of their insane inmates'; minutes (9 August 1905) include summary of letter from Manager, Castlecomer Collieries, County Kilkenny, dated 5 August 1905, requesting Asylum to use Irish coal. Noted that Irish coal is used as far as possible; report (11 October 1905) of the Resident Medical Superintendent states that for the first time in the history of the institution, the number of female patients has reached two hundred.

11 April 1906-8 January 1908

Minute book of the Board of Governors of Carlow District Lunatic Asylum. This is a pre-printed minute book. Same layout as SDH/001/011. Minutes (8 August 1906) include transcription of testimonial given by the Joint Committee to Dr J.J. Fitzgerald, Resident Medical Superintendent, in connection with his application for the same position at Cork District Asylum; minutes (12 September 1906) refer to agreement between the Joint Committee and John Whelan regarding the Committee's lease of land from Whelan at Rathnaphish and Pollerton, County Carlow. There are earlier references to discussions about these lands in the minutes of meetings held on 23 April 1906, 3 May 1906 and 9 May 1906; minutes (14 November 1906) include resolution that that the carpenter, shoemaker and tailor be granted clothing in the same manner as other male attendants; minutes (27 February 1907) record acceptance of resignation of Dr Fitzgerald as Resident Medical Superintendent; minutes (15 May 1907) include proposal that the salary of the Resident Medical Superintendent be fixed at £350 per annum with additional allowances totalling £150, including provision for a partly-furnished house; minutes (12 June 1907) include direction to the Acting Resident Superintendent to write to the Board of Guardians, Carlow Poor Law Union, 'in reference to the transference from the Union to the Asylum of old harmless and infirm patients who could not in any way be considered as requiring asylum treatment to point out that if such cases continue to be sent the Asylum accommodation will be seriously effected [sic]'; minutes (11 September 1907) include resolution that the appointment of Dr Edward J. Board to consider lighting the Asylum by electricity. Resident Medical Superintendent directed to write to Alexander to request estimate; resolution (12 October 1910) that the Joint Committee protests against the proposed reduction of 32% from the grant in aid hitherto paid from the Local Taxation account in respect of the cost of maintenance of pauper lunatics at the rate of four shillings per person per week. [Irish Church] patients; minutes (10 April 1896) note attendance at meeting of Quilton, Carlow County Surveyor. Informs Governors that the cost of taking a water supply from the river Barrow would be circa £800; minutes (14 August 1896) state that deputation from the Carlow Town Commissioners attended meeting and agreement on reached on water supply. Asylum is to take 16,000 gallons of water per day at rate of 5 pence per 1,000 gallons. Maximum charge of £120 per annum; minutes (9 July 1897) note that Governors approve plans by Quilton, Carlow County Surveyor, for enlargement of Roman Catholic chapel and resolve that Board of Control be requested to obtain loan of £850 to facilitate works.

This report also includes a section on Wexford Local Asylum which accommodates 16 patients. It is described as a 'remnant of the old poor-house system in Wexford' and that it is intended to transfer the patients to Carlow or return them to relatives. Also includes section on the County and City of Kilkenny Pauper Lunatic Asylum which is under the care of the Board of Superintendence of the county gaol. It is supported by grand jury presentments; Appendix No. 3 comprises the General Rules for the Government of all the District Lunatic Asylums in Ireland, made, framed, and established by the Lord Lieutenant and Council of Ireland, March 27, 1843. It includes rules for meetings of the Board of Governors, admission and treatment of patients, and duties of officers and servants; Report (1844) states that the mode of heating Carlow District Lunatic Asylum is by fires in the corridors, and that they do not provide sufficient warmth. There is also a reference to fires in the day rooms. Noted that the Asylum occupies 15 acres and 39 perches statute measure of which around 10 acres are available for agriculture; patients are classified thus: violent and highly excitable, refractory

classes, less violent and quiet classes, and the convalescent. The 1844 Report includes section on the County and City of Kilkenny Local Lunatic Asylum. It states that no new case is taken into this asylum unless the District Asylum in Carlow is unable to accommodate the patient; Report (1845) includes sections on both the Wexford Local Lunatic Asylum and Wexford Asylum; Report (1846) states, regarding Carlow District Lunatic Asylum, that it employs seven officers and 31 servants, 23 of whom are exclusively employed in attending to patients. This affords average of one attendant to eight and a fraction patients. Report includes discussion of moral and medical treatment at the Asylum. The 1846 Report includes transcription of letter dated 23 May 1846 from Thomas Haughton, Member of Board of Governors and Directors, Carlow District Lunatic Asylum, to Dr Francis White, Inspector of Lunatic Asylums, in which he mentions that Mr Lynch, architect, examined the Asylum buildings [probably Joseph Lynch, Carlow, architect]; Report (1848) refers to the death, within the last year, of William Parsons, Manager, Carlow District Lunatic Asylum. He was succeeded by Dr Matthew Esmonde White, formerly the visiting physician, in accordance with the principle of appointing 'professional gentlemen to the office of resident managers.' Report mentions that existing regulations will have to be revised to define duties of medical attendants. The 1848 Report also discusses increased mortality during 1847, the worst year of the Great Famine. Notes that during 1847, there were 422 deaths in district lunatic asylums and 122 deaths in gaols. This was an increase over the preceding year by 224 and 47 respectively. Mortality decreased during 1848; Report (1857) states that Carlow District Lunatic Asylum was built to accommodate 104 patients. There have not been any additions or alterations but by, 'a better regulation of the sleeping apartments, room was obtained for 96 additional inmates.'
